# C. Glocester Town Budget 2020-2021

- 1. Review of Budget and/or Amendments to Budget: Town CouncilDiscussion and/or action Discussion: Councilor G. Steere stated there has been a lot of discussion on the budget and there may be a few changes. Councilor G. Steere invited D. Brennan to explain.
- D. Brennan explained some of the amendments proposed:

The Regional School District adopted a number, Tuesday night, that was slightlyless than what was originally proposed in our budget. (\$32,000 reduction)

Revaluation item was moved out of Capital (\$35,000) and moved into operations.

Diane Brennan explained a chart she prepared for Council that included Operational expenses being funded in part from surplus, at different levels, and increases to tax rates resulting from her scenarios, which included housing values.

Councilor G. Steere discussed that some Council members were concerned with the concept of using \$604,000 from the Fund Balance of \$800,000 towards operations. Councilor G. Steere also expressed his concerns of the possibility of creating a structural deficit going forward. Councilor G. Steere stated one of the scenarios would bring down the amount out of the Fund Balance use of \$604,000 to \$298,000 with a tax increase of 1.5%. Councilor G. Steere stated he felt that could be made up by growth in the coming year. Discussion followed on growth numbers in town; not wanting to increase taxes; and revaluation impact.

Councilor Henry questioned the town's high tangible tax rate. D. Brennan stated she just has always maintained the ratio between all rates in town. Councilor W. Steere stated this would be a good question for the Tax Assessor. D. Brennan stated that she would recommend a change to that particular tax rate be done over time if the Council decides to change it. P. Henry spoke about a possible tax rate increase; her response from residents in our current world situation; and previous years budgets. Councilor Henry questioned raising taxes while holdingon to 17% Fund Balance. Councilor W. Steere discussed the unknowns coming forward financially on a state wide level. Councilor W. Steere stated he hopes residents understand the problems are state is having in light of these unknowns, and referenced unknown funding formulas and reimbursements. Councilor W. Steere stated if we level fund this year there could possibly be a 4% + increase next year at a time when we, as residents, cannot handle it. Councilor Forgue stated he does not want to pay more taxes but stressed we must be prepared, especially if the state cuts funding. Council members talked, at length, regarding the budget, taxation, school funding, and the current state of financial affairs.
