# RE: WWAM PROPERTIES, LLC DECISION

This matter came before the Board on October 28, 2021 upon the petition of the owner, WW AM Properties, LLC and the applicants, James C. Lykas and Heather L. Lykas, to operate a canine day care and boarding kennel on property owned by WWAM Properties, LLC at 399-401 Putnam Pike, AP 17, Lot 190. The property is located in a B-1 Neighborhood Commercial Zone, which does not allow kennels and/or animal boarding, under Chapter 350 Article II, use regulations Section 1, Subsection 3. A minimum lot size of five acres and a one hundred foot set back from property lines is required for such uses where it is permitted. The owners and applicants have requested a use variance along with a dimensional variance of 3.41 acres of relief from the minimum lot size requirement and ninety-two feet of relief from the one hundred foot set back from property lines.

#### CONCLUSION

At the close of the public hearing, a motion was made by Member Harkness to grant the request for a use variation and it was seconded by Member Kelman. The motion was approved unanimously, Members Meinertz, Harkness, Kelman, Martone and Anderson all voting in favor. A condition of this grant was imposed limiting the number of kenneled dogs to fourteen and a maximum of forty-five dogs for day care.

A second motion to grant the dimensional relief requested of 3.14 acres of area required and 92 feet from property lines was made by Member Harkness and seconded by Member Martone. The motion passed unanimously, Members Meinertz, Harkness, Kelman, Martone and Anderson all voting in favor.

According to Section 300-32 of the Subdivision Regulations, Construction and Improvement Guarantees, upon completion of all required improvements, the applicant shall convey all public improvements to the Town of Glocester for ownership and maintenance. Applicant Adler Brothers Development, LLC, has requested in writing that Pond View Court and the associated drainage be accepted for maintenance by the Town of Glocester. The members of the Technical Review Committee have reviewed the subject Road Dedication materials and plans titled "As-Build Plan-Pond View Court" prepared by Richard Bzdyra, PLS dated September 29,2021. This application was certified complete in content by the administrative officer on December 8, 2021. The Technical Review Committee reports the following:

Findings:

- 1. Final approval of a major subdivision to subdivide AP 13, Lot 163, consisting of 36.89 acres into six (6) lots for single family homes was approved on December 9, 2019.
- 2. The Final plat creating the lots was recorded on September 3, 2020 (HF 519, Map 922)
- 3. The applicant has submitted all the required information for dedication including a description of all facilities to be accepted accompanied by an accurate description of the

street and drainage easements, a set of as-built plans accepted by the Administrative Officer, and executed deeds and easements transferring ownership to the Town of Glocester.

4. The facilities have been inspected by the Public Works Director, who has certified in writing that all required improvements have been satisfactorily completed in a letter dated November 24, 2021.

**Recommendations:** 

- 1. As directed by Section 300-32 G. 2 of the Subdivision Regulations, the Technical Review Committee finds that all requirements for road dedication have been met and makes a recommendation for acceptance by the Town Council.
- 2. As directed by Section 300-32 G. 3 of the Subdivision Regulations, the Technical Review Committee recommends that the maintenance bond requirement be waived for this dedication. The binder course has been in place for this roadway for over one year and has performed as expected.
- 3. Upon acceptance by the Town Council, the applicant shall record the as-built plans, deed and easement with the Town Clerk. Once recorded, all public improvements shall be permanently owned and maintained by the Town of Glocester as part of the Town of Glocester system and the applicant shall no longer be responsible for their care, repair or appearance.
