- **Whereas:** the Blackstone River became the first industrialized river as well as the first polluted river way in the Western Hemisphere, and
- Whereas: Samuel Slater, on the Blackstone River in 1790, launched the American Industrial Revolution, and initiated economic freedom for the United States where the use of the Blackstone River's waterpower offered the strength needed to power hundreds of textile mills along its 48 mile length and these mills employed thousands of people that arrived from all over the world, in search of their American Dream, and

- Whereas; while this economic opportunity catapulted the Blackstone Valley businesses into a world economy for almost 200 years, it also left a legacy of environmental degradation, an environmental condition that has denied ten generations the use of the Blackstone River for drinking, swimming or eating its aquatic life, and
- **Whereas:** *Operation ZAP,* an environmental movement in the Blackstone River Valley, was organized in 1972, with a mission to clean the Blackstone River making it possible for future generations to enjoy living along a clean river way, and
- Whereas; Operation ZAP coincided with the founding of Earth Day and in the United States Congress' passage of the Clean Air and Clean Water Acts, and the founding of Save the Bay, and was conceived and organized by David M. Rosser of Pawtucket, Rhode Island, the then President of the Blackstone River Watershed Association, where on September 9, 1972 Mr. Rosser, with the help of hundreds of community leaders and businesses, organized more than 10,000 people to remove tons of refuse from the banks of the Blackstone River and begin the creation of riverfront parks, and
- Whereas; since that time the Blackstone River has seen millions of dollars of federal, state and local money spent on continuing the clean-up efforts, and has become cleaner for fish and wildlife, and
- Whereas;the Blackstone Valley Tourism Council is organizing an effort, with dozens of<br/>local volunteer groups and individuals, with the goal of organizing 10,001 people,<br/>to celebrate the people and groups that have helped clean the Blackstone River,<br/>and
- Whereas;it is time to be a part of this environmental movement, this time through out the<br/>entire Blackstone River Watershed, to clean up and green up the 25 Blackstone<br/>River Watershed communities from Worcester, Massachusetts to Providence,<br/>Rhode Island, and
- **Whereas:** the Rosser family, is working with the local organizers of ZAP50 to insure the environmental legacy is continued, and is a time to celebrate the people who worked on *Operation ZAP* in 1972 and the organizations and people who continue the work to bring the Blackstone River back to health, and therefore

The Town of Glocester joins ZAP 50, to be with the 10,001 people that will assemble on August 27, 2022 to clean the Watershed and will assemble again on September 10, 2022 at the Old Slater Mill National Historic Site in Pawtucket, to celebrate.

The Town of Glocester commits its leadership and will promote participation to assist in mobilizing its citizens to "turn out" to join the 50th Anniversary of *Operation ZAP*. We call upon all to honor the work performed in 1972, honor the groups and agencies for the past and current ongoing efforts, and ensure that the *Operation ZAP of 1972* goals are realized.

XIII. New Business

A. Request from Town of Foster - RE: Assistance with Animal Control - Discussion and/or Action

Councilor Reichert stated that the Chief has received a request from the Town of Foster.

Discussion: Chief Delprete explained that he received a request from the Town of Foster for Glocester to consider taking over the management of the Foster Animal Control Office for a payment of \$30,000 per year. Chief Delprete explained that Scituate is currently handling the Town of Foster and has proposed a large increase in the fee from Foster.

Chief Delprete outlined the potential challenges if Glocester were to take on that responsibility including but not limited to the large area of Foster; the fact that the Glocester Animal Control Officer is new to the position and still learning; that additional personnel would have to be hired; that a Glocester Police Officer may need to accompany the Glocester ACO to calls in Foster if a Foster officer were not available; and, the different types of animals that may be involved. Councilor Arnold stated his opinion that the money was low. Councilor Reichert stated that the Town Council President of Foster called him to discuss the matter . Councilor Reichert stated that the \$30,000 seemed low for the job. Councilor Laplante asked why Scituate no longer wants to continue to manage the Foster animal control office. Chief Delprete stated that the money was too low and if Scituate were to continue to manage the Foster animal control office then they would be asking for \$51,000 per year. Councilor Worthy stated he feels uncomfortable making a motion due to the fluctuations in costs he has received but stated that if they were to consider this request, more due diligence would be required. Chief Delprete stated that Foster would want a three year commitment. Councilors Laplante and Steere also stated their opinion to not take on this responsibility at this time.

Matt Floor is currently looking over the documents from an IT stand point and says that we are looking at a realistic program deployment date for the second week in May. This gives us some time to finalize these policies.

One of the main questions that I have is in regards to the iPads that may sustain damage, or are never returned. I would assume there would be some sort of repercussion put into place. In this agreement, I have stated that they would need to be repaired or replaced at the expense of the borrower, but I am not sure what direction the Town Council would choose to take.

I also stated that this program is available to members of the Glocester Senior Center who are in good standing. That would also include members who live out of town. Is this a direction that the Council is comfortable with? Should we also make it available to residents of Glocester who are not members of the Glocester Senior Center? I would like to include an announcement about this program in our May newsletter that goes out next week, therefore I was hoping for Council to come to a definite conclusion at this meeting as to whom will be eligible to participate in this iPad Loan Program.

I am open to any other suggestions that I may have overlooked. Thank you for your time and consideration.
