A. Muccino explained that a tax bill can't be sent without the valuation because the town's bon counsel will not authorize it and if the town sends anyway then that would decrease the town's bond rating. P. Henry, resident, stated that during her time on the Council two councilors would always go together to speak with FM so she wanted to know when the Council lost track of FM. P. Henry stated that it is shocking to be in such a situation with the town's best neighbor. Councilor Laplante stated that corporate people are different from the local FM people. Councilor Laplante stated that the Council is working on getting a proper appraiser by a qualified company and that there have been two bids at \$250,000.00. Councilor Reichert stated that the funding would come from ARPA funds in response to a question.

Greathouse, resident, stated that the majority of people did not know about the Financial Town Referendum and agrees with a Facebook page. P. Henry, resident, stated her support of a facebook page and feels that the town website is not current. D. Igliozzi ,town solicitor, stated that the Town Council would need to come up with rules as to a facebook page. Councilor Laplante suggested having a standard item on every agenda being facebook information. Councilor Arnold stated that the ability to comment on the page can be turned off so it can just be information and it could link back to the town website. R. Shields, Recreation Director, offered suggested a short term solution of putting information on an existing page until

Lemos asked the Council to get the field to something the town can be proud of. T. Lemos also described the calendar of the Rec. Comm during the year with a list of proposed events. A. Dunn, Rec. Comm. Member, described how he would run the cycling proposed event and also stated the need for work to be done on Leja field. S. Sabatos, stated that the was the assistant coach for Ponaganset Middle School baseball team and that he was asking for help with the field as the team used it often last year. G. Treml, DPW Director stated that the field was mowed all summer; the infield was changed three times; the infield has sprinklers; and described other work done by the department. G. Treml stated that his department was given a schedule for mowing and they did it for the entire season. S. Sabatos stated the grass is being cut and the middle school team uses the field about four times per week from March trough November.
