2022 SNEP Watershed Implementation Grants - Subrecipient Agreement

Between Restore America's Estuaries and Town of Glocester, RI

Grant Agreement #SWIG22-1-GLO - Discussion and/or Action

Councilor Reichert stated that Council has received a request from the Town Planner for authorization regarding an agreement between the Town of Glocester and Restore America's Estuaries under the 2022 SNEP Watershed Implementation Grants which he read as follows:

To: Town Council Members
From: Karen Scott, Town Planner

Date: November 16, 2022

RE: Authorization for Signature – 2022 Watershed Implementation Grant

The Town received a Watershed Implementation Grant from the Southern New England Partnership for \$250,000 for an Implementation Plan for Chepachet Village Wastewater Improvements.

Using RIDEM wastewater permit data, the Town has identified the locations of known and suspected cesspool locations and the locations and sizes of holding tanks. These types of wastewater management systems are likely to be pollution discharge points, impacting the drinking water in the Village and the surface water quality in the Chepachet River. In cooperation with local and state partners, the Town will conduct a vigorous outreach and communication program to target the parcels noted above to establish reliable wastewater management systems within the Village area. This project will establish a financial incentive for participation, monitoring parameters, covenants and a third party monitoring entity to ensure long term success.

This grant requires a 33% match which is being satisfied by \$200,000 in ARPA funds and limited staff time. There is no cash contribution to this grant from the Town. I am requesting authorization for the Town Council President to sign the grant agreement.

Discussion: K. Scott, gave a detailed explanation as to how she has successfully received grants and then found matching grants for projects in order for the town to have little to no monetary responsibility in many projects. K. Scott described several projects that are part of the thirty year old Comprehensive Community Plan that have benefitted from her successful obtaining of grants and

matching funds. K. Scott described that the water feasibility study is for \$125,000 of which \$40,000 was a Commerce grant and the remaining \$85,000 was a grant from the RI Infrastructure Bank. K. Scott stated that the item before the Council tonight has to do with the wastewater in the village. K. Scott stated that this grant is for \$250,000 with an additional match of \$200,000 of federal American Rescue Plan Act (ARPA) funds that were approved by the Council at a previous meeting. K. Scott stated that the only in kind match is for her time which averages to about one and one half hours per week. Council thanked K. Scott for her hard work as did a number of the audience in attendance.

D. Resident request for consideration of waiver of fees for Access to Public Records request- Discussion and/or action

Discussion: Councilor Worthy requested this item on behalf of resident L. Gaddis Barrett who has requested multiple Access to Public Records (APRA) requests through the Town Clerk's office. When asked how these fee requests have been handled in the past, J. Fecteau, Town Clerk, stated that she has not had to charge any one for an APRA request in over a year because the answer(s) have been readily available. J. Fecteau stated that some of the requests from this individual may be readily answerable but that over half of the requests would require her to interpret what someone meant in a statement which is not something she should do. J. Fecteau stated that the request may result in none or minimal fees but it could also cost a lot due to time, so she was just preparing for that possibility when she sent the request for fees. J. Fecteau suggested, if the Town Council was in agreement, to not ask for a down payment of the fees and trust that L. Gaddis Barrett would pay the fee, if any, that was owed. L. Gaddis Barrett stated she deliberately structured her requests for a no answer. J. Fecteau stated that over half of the requests were too vague and were asking for interpretation of what another person "meant" by their statements. L. Gaddis Barrett stated she was asking for communication items such as emails, text messages and social media posts. J. Fecteau stated she could not research social media posts as she does not go on social media and she could try to get the information, if available, from the appropriate public body. J. Fecteau stated she is trying to help L. Gaddis Barrett but needs clarification as to the vague requests. L. Gaddis Barrett stated her opinion that she feels J. Fecteau just said she would ignore a public records request. J. Fecteau stated she did not say that she would ignore a request but that she will pass the request on to the Solicitor. Attorney Igliozzi explained that public document requests come from the public body who possess them. Attorney Igliozzi stated that some of the requests from L. Gaddis Barrett are vague and that she can't ask for interpretation but rather APRA requests are for documents. D. Igliozzi recommended that the requests be clarified and then we can determine the appropriate public body to answer. D. Igliozzi offered to work with L. Gaddis Barrett to clarify her requests and report back to the Council at which time the Council may consider the waiver of fees request.

D. SPECIAL EVENT LICENSE RENEWALS - Request for 2023 Outdoor Special Events

1. Robin Tyo, Tyo Ristaino Corp d/b/a Cadys Tavern 2168 Putnam Pike

Discussion: D.Igliozzi, Town Solicitor, stated the issue is whether the advertisement and the abutter notice adequately provide notice of what is being requested. D. Igliozzi stated that the issue of outdoor amplified music is a substantive part of this special event license and there are enough discrepancies between the ad and the abutter notice to raise the question of whether sufficient and adequate notice was provided. D. Igliozzi recommended that this matter be continued to December 15<sup>th</sup> in order to clarify the advertisement and the abutter notice. D. Igliozzi also recommended that the clarified ad and abutter notices be re sent and re advertised. D. Igliozzi stated that Mulberry Vineyards did have the proper notice as to outdoor amplified music so that request could be heard tonight.

D. D'Agostino, attorney for Hill's Tavern; and, Robin Tyo of Cady's stated that they had no objection to continuing the public hearing to a date certain.

# 3. David Wright, Mulberry Vineyards 95 Pound Road

Councilor Reichert stated that this Public Hearing was advertised in the Valley Breeze/Observer on November 3<sup>rd</sup>, 2022.

Councilor Reichert DECLARED the Public Hearing OPEN

Councilor Reichert asked if anyone wished to speak regarding the license renewals.

#### Discussion:

- D. Colantonio, resident, stated that the music is still too loud; that it is becoming an event venue not a vineyard and he would like the Council to deny the special event license as it is a residential neighborhood.
- R. Rogers, resident, questioned the number of events being requested as well as the time frames for the events and type of events. R. Rogers stated that there is not enough information for a decision to be made.
- D. Wright, stated that he is requesting 18 events; that he has made changes regarding moving the stage; added signs for parking; has people helping with parking.
- D. Wright described the noise analysis he performed at various events and gave the Council a printout of the decibel readings . D. Wright stated that the decibel readings did not go over 60 decibels and averaged at 39 decibels. D. Wright stated that all of the police reports stated that the music was low and issues as to loudness were unfounded. Councilor Arnold feels that D. Wright needs to be clearer as to the specifics of the requested events especially as D. Wright had failed to disclose a wedding event . D. Wright stated they could not specify dates and times of bookings as they have not made any yet. Councilor Worthy asked if any weddings were scheduled. D. Wright stated no.
- D. Igliozzi stated that what was approved by Zoning Board is different from what the Town Council, acting as the Licensing Board, can consider and approve. Councilor Laplante would like the applicant to clarify the application with more specific dates, times and details as to each event and music. Councilor Laplante stated he went out to Mulberry Vineyard when called and listened to the music and it was loud. Councilor Laplante stated that Mulberry needs to try and work with the neighborhood to find a resolution just like Cady's and Hill's have both done successfully. Councilor Arnold recognizes the difficulty of actual dates but time frames can be specified.
- D. Wright stated that he understood the licensing process to be a general request for the number of events and then be more detailed on the individual actual application for the specific event. D. Wright stated they are asking for a couple more events from last year. J. Fecteau stated that no applicant gives specific days and times but they do describe the events being proposed with more details. Councilor Worthy stated that this vineyard is in a residential neighborhood for producing crops and not to make a profit with alcohol. Councilor Worthy described his opinion of the inability of Mulberry to control the noise on the property and that the neighbors continue to complain. Councilor Worthy stated he would like to deny the special event license. Councilor Laplante stated

that more information describing the events as to time, day, and type but not necessarily the exact dates was needed. Councilor Steere stated that this problem has been experienced at other locations and they have worked out the issue. Councilor Steere stated that without more clear information on the application it is difficult for the Council to make a decision. D. Wright stated he would be happy to clarify the application and re submit it. Attorney Igliozzi stated that based on the testimony that the application is insufficient recommended the Council continue Mulberry special event license application to a date certain . Councilor Arnold suggested to continue to Dec 15<sup>th</sup> to include with Cady's and Hill's applications. J. Fecteau stated that the application would need to be done before Dec 15<sup>th</sup> . J. Fecteau stated that she could include Mulberry Vineyard on the ad she is sending out tomorrow for Cady's and Hill's.

K. Lavoie, Pound Road, stated that Mulberry Vineyard has developed into an event venue in the middle of a residential neighborhood. K. Lavoie suggested that the special event license be denied and for the applicant to stick to the original intent. H. Stanley stated that the noise issue has not been addressed and that many events are no problem. D. Colantonio complained again that this is a business in a residential neighborhood and then extolled on what the vineyard can or cannot grow; what they may or may not have grown and that there is no middle ground as far as a compromise.

D. Wright described the steps the vineyard has taken in the actual growing of grapes for wine.

Councilor Arnold feels that more specific information regarding the request is needed for the Council to be able to make a decision as to the special event license.

Attorney Igliozzi stated that the applicant should demonstrate he is in compliance with the law as to a winery because the issue was raised by the public; that the compliance as a winery does not give the applicant a license for amplified music; that the applicant should demonstrate compliance with zoning requirements but that compliance has nothing to do with licensing for music. D. Igliozzi stated the Council is the proper authority to grant or deny the license as to outdoor music in this particular location if they feel it is appropriate. D. Wright stated that the Vineyard is in compliance with the RI Division of Taxation and that they have received their renewal license as a winery.

MOTION was made by Councilor Steere to continue the public hearing to a date certain ,December 15<sup>th</sup>, with notice to abutters and advertisement and to amend the application to address the issues raised by the Council; seconded by Councilor Arnold

# XII. Open Forum

Councilor Reichert asked if anyone signed up to speak and when called to the podium, state your name for the record.

1. M. Rizzo, resident, asked if a decision had been made regarding the vacancy in the School Committee. D. Igliozzi stated that he and the Town Clerk had done a great deal of research into this matter. D. Igliozzi stated that the Glocester Charter is accurate as written because all amendments have been properly ratified by the General Assembly including the ballot question in 2000 which changed the language in case of a tie from the school committee choosing to the town council choosing. D. Igliozzi explained that the ballot question was a bit vague but that it basically asked if the Charter shall be amended to be in conformity with state law. D. Igliozzi stated that state law does not have any language about how the seat is to be filled or what happens in the event of a tie. D. Igliozzi stated that the state law does have the language of the Council filling the seat. D. Igliozzi explained that the Glocester Charter prior to 2000 authorized the school committee to fill the vacancy in the event of a tie and that the 4<sup>th</sup> vote getter would take the vacant seat if there was no tie. D. Igliozzi further stated that in 2000, because of the approved ballot question, the Charter was changed to authorize the

town council to fill a vacancy if there was a tie and not the school committee. D. Igliozzi stated that the Charter as written can be verified in five ways: 1) a comparison of the old and new language in the charter; 2) all amendments have been ratified by the General Assembly; 3) a memo dated 7/20/2000 by the former town solicitor; 4) there was a quote by the current town clerk in a newspaper report stating that the only two words being changed in the charter were school committee to town council; and, 5) the minutes from the public hearing. Based on all of this evidence, D. Igliozzi stated that the Charter as written is clear that the fourth vote getter is the successor to the seat that becomes effective upon a resignation and upon certification of the placement by the Board of Canvassers. D. Igliozzi also stated that it is the results from the November 8, 2022 election that applies.

J. Fecteau stated that the highest vote getter in the race for Town Sergeant by write in votes is Albert Aubin and he is to be certified by the Board of Canvassers on Tuesday.
