WHEREAS; on July 27, 2022, the Town of Glocester entered into a purchase and sale agreement ("Agreement") by and between RENE D. PIGEON and PATRICIA E. MANN with a mailing address of 1465 Putnam Pike, Chepachet, RI 02814 ("Seller") and the Town of Glocester, a Rhode Island Municipal Corporation ("Buyer") with a mailing address 1145 Putnam Pike, P.O. Box B, Chepachet, RI 02814; and

WHEREAS; the Agreement provided that the Seller agrees to SELL AND CONVEY, and the Buyer agrees to BUY that certain lot or parcel of land, together with all buildings and improvements

thereon, located at 1272 Putnam Pike, Chepachet, RI 02814, assessor's plat 10A lot 47, more particularly described on Exhibit A attached hereto ("Property"), and

WHEREAS; the Buyer has appropriated Three Hundred and Sixty Thousand Dollars and 00/100 (\$360,000.00) for the purchase of this Property from the American Rescue Plan Act (ARP A) funds distributed to the Town of Glocester.

WHEREAS; the Agreement further provided that in consideration of the executed Deed, the Buyer will pay to the Sellers the sum of Three Hundred and Sixty Thousand Dollars and 00/100 (\$360,000.00) payable as follows: \$360,000.00 due and payable at closing by cash, certified check, and/or bank check, and

WHEREAS; the Agreement was subject to several contingencies that have been satisfied.

NOW THEREFORE BE IT RESOLVED that the Glocester Town Council hereby approves the purchase of that certain lot or parcel of land, together with all buildings and improvements thereon, located at 1272 Putnam Pike, Chepachet, RI 02814, assessor's plat l0A lot 47, more particularly described on Exhibit A attached hereto, and in consideration of the executed Deed, the Town will pay to the Sellers the sum of Three Hundred and Sixty Thousand Dollars and 00/100 (\$360,000.00) from the ARPA funds payable at closing by cash, certified check, and/ or bank check.
