D. Proposal from Senator G. Rogers (Foster) re: proposed regional coalition - Discussion and/or Action

Senator Rogers discussed the differences between small towns and larger cities especially when in regards to achieving the 10% affordable housing requirements. Sen. Rogers expressed his concerns with legislation that could take away the small communities zoning authority. Sen. Rogers gave examples of "trampling density" limits of small communities and what the effects could be.

Sen. Rogers also spoke on the lack of public transportation in rural areas affecting our ability to reach housing goals. Sen. Rogers discussed a commerce park, funded with state assistance, as one of the solutions to consider. Sen. Rogers distributed printed material to the Council.

At the January 10th 2023 Board of Contracts meeting, the Board voted to have the Finance Office review the bid for compliance.

The Board of Contracts and Purchases met again on January 30th 2023. At the meeting, the Board voted to recommend to the Town Council that the Council award IFB 2022-08 to Reichert & Sons

Councilor W. Steere stated that he had spoken to J. Luszcz about a grant from the RI Foundation and he would forward the information to J. Luszcz.

XIV. Open Forum

Councilor W. Worthy asked if anyone would like to speak and if so to step up to the microphone and state your name for the record.

1. Odete McMahon, resident, stated her concerns as to the potential affordable housing in Chepachet Village. O. McMahon suggested to help the Glocester low income and elderly residents first. O. McMahon stated her concern that

the proposal by G. Rogers of a commerce park would open the door for the large box stores as in Smithfield. O. McMahon stated her opinion to keep Glocester rural.

2. Councilor S. Arnold read a letter received from resident D. Laplante stating his opinions and concerns against affordable housing:

To: The Honorable Glocester Town Council From: David Laplante, 47 Absalona Hill Road

RE: Affordable Housing

Members of the Town Council

Recently there has been a lot of talk concerning the construction of up to 38 affordable housing units in the Chepachet village area. As reported in the news, Neighborworks Blackstone river Valley along with financing from Rhode Island Housing and using ARPA funds have purchased the former Purple Cat Winery along with an adjoining 19 acre lot with a plan to create 38 units of affordable housing. Myself and many other residents have concerns.

One major issue is where the multi housing will be located. That area of Glocester has a serious issue concerning clean water. As those of you on the Council are aware, most of the center of Chepachet has contaminated water.

Another issue is the restrictions on septic in that area due to wetlands. The solution according to the developer and the State? Composting toilets. This is an extremely bad plan. Composting toilets need a lot of maintenance and careful usage and severe restrictions as to what can go into a composting toilet. People, especially with young children will not give the care and diligence that these systems require, especially in a multiple unit rental setting.

Of course if a developer attempted to place 38 units of regular condominiums in this spot, the project would be denied because of the issues I previously stated. This project however, has the backing of Rhode Island Housing and the State of Rhode Island General Assembly which has become a far left organization that will push their agenda with total disregard for the towns ability to support such an agenda.

Republican Senator Gordon Rogers along with a minority group of other Senators and Representatives are warning that the State is contemplating enacting laws to override local planning and zoning in order to force towns to allow the building of affordable housing units regardless of the negative environmental and social impacts that this rush to urbanize outlying areas would have. Senator Rogers said he is trying to form a coalition to lobby to preserve the rights and sovereignty of rural towns that don't have the infrastructure to support what the State is trying to force on us. I would ask that the Glocester Town Council meet and speak with Senator Rogers and if such a coalition is created, to join the coalition in order to preserve local planning and zoning.

I am not advocating that there should be no affordable housing. I am merely saying that for any type of housing to be approved and built, that housing should conform to local planning and zoning ordinances, not rules and laws set by an overreaching state government or agency. The residents of Glocester and their elected officials are the guardians of our local environmental health and what does and does not impact it, not a meddling and overreaching State or Federal government.

My intent was to appear before the Council in person at the February 2, 2023 meeting but my wife Missy had unexpected surgery on Monday January 30th and needs me to be home to assist in her care.

- P. Henry, resident, thanked Senator Rogers for coming to Glocester tonight. P. Henry stated she liked the coalition idea but in her opinion that the town push back at the state by suggesting Glocester ask the state to be 5% affordable housing and not the 10% mandated as Glocester won't be able to meet the 10%. P. Henry stated the reasons she feels Glocester won't be able to meet the 10% as: the 100% septic system reliance; the strain on the police department and volunteer fire companies, the strain on traffic control, and the importance of our precious acquifer. P. Henry questioned the purchase of this property by the same entity after the last attempt. P. Henry stated her opinion to recommend Glocester join the coalition proposed by G. Rogers but not to recommend the commerce park concept.
- 4. C. Wilson, resident, stated his opinion that the affordable housing could destroy the historic homes and the Historic District. C. Wilson suggested the Town Council work on this matter.
- 5. E. Dauphinais, resident, stated her agreement with O. McMahon and P. Henry. E. Dauphinais stated there are many elderly residents with low income who have been on a waiting list in town for housing that need help. Ms. Dauphinais stated, however, that there would be a strain on the police and fire departments; that there is no trash pick up in town so that would be a separate issue; and, that there is no public water as the town is entirely supplied by wells.
- 6. B. Leach, resident, asked about a claim he submitted. G. Treml stated the claim was forwarded to the Town's insurance provider, the Interlocal Trust.
- 7. A. Broccoli, stated that he appreciated what has been said and stated his opinion that the current laws should change to allow the over 55 housing, in law units and Section 8 housing to be counted towards the affordable housing requirement.
