2. Resolution in support of the introduction and passage of legislation in the Rhode Island General Assembly that will: (1) allow the Town of Glocester a one-year levy cap exception for fiscal year 2026 with a maximum total levy increase not to exceed 3.0%; and (2) allow the Town of Glocester to adopt a supplemental tax levy for Fiscal Year 2026 pursuant to a Special Financial Town Referendum.

Councilor W. Steere read the Resolution as follows:

GLOCESTER TOWN COUNCIL RESOLUTION FOR TAX LEVY INCREASE LIMIT AND SUPPLEMENTAL TAX FOR 2026

WHEREAS: Rhode Island General laws Section 44-5-2 only allows municipalities to increase their levy by a maximum of 4% each year, barring special conditions.

WHEREAS: On May 20, 2025, the Town of Glocester (Town) approved a budget referendum with a 4% increase for fiscal year 2026 that included an increase of 6% for the Glocester School Department (School Department).

WHEREAS: Notwithstanding the increase in funding, the School Department in fiscal year 2026 will face a significant budget shortfall that will require the School Department to lay off teachers and teacher assistants and significantly reduce critical student services. The proposed School Department layoffs and the reduction of student services will have a significant impact on student achievement, disciplinary behavior, and the broader educational environment.

WHEREAS: Notwithstanding the increase in funding, the Glocester School Committee has notified the Town of a potential claim for lack of maintenance of effort.

WHEREAS: To provide additional funding for the School Department, state legislation is required to authorize the Town of Glocester to levy a supplemental tax, by voter referendum, that exceeds the current tax cap by not more than three percent (3%) for fiscal year 2026, in order to fund School Department operations and avoid a loss of critical town services.

NOW THEREFORE, to appropriate additional funding for the School Department in order to fund the School Department operations and avoid a loss of critical town services.

IT IS HEREBY RESOLVED that the Glocester Town Council supports **House Bill 2025-H 6409** that will authorize the Town of Glocester to levy a supplemental tax, by voter referendum, that exceeds the current tax cap by not more than three percent (3%) for fiscal year 2026, in order to fund School Department operations and to avoid loss of critical town services.

IT IS HEREBY FURTHER RESOLVED that the Glocester Town Council supports the introduction and passage of additional, substitute and/or companion legislation in the Rhode Island General Assembly that will authorize the Town of Glocester to levy a supplemental tax, by voter referendum, that exceeds the current tax cap by not more than three percent (3%) for fiscal year 2026, in order to fund School Department operations and avoid a loss of critical town services.
