VII. New Business

A. Voter Referendum

1. Approval of Ballot question – Discussion and/or Action Councilor W. Worthy stated that the Clerk has received the referendum calendar as set by the RI Board of Elections. Councilor W. Worthy stated that the choices are September $2^{\rm nd}$ or October $7^{\rm th}$.

Discussion:

Councilor W. Worthy stated that if after discussion tonight, Council does not vote on a final question, a special Town Council meeting will have to be held by July 9th to give the Clerk time to hold a special meeting of the Board of Canvassers for final certification.

Councilor J. Burlingame stated that he spoke briefly with the Superintendent yesterday and she is working on the budget. Councilor J. Burlingame stated his opinion that he is not sure if the Superintendent will have a recommendation ready for Council prior to July 9th. Councilor J. Burlingame stated his opinion that he feels Council needs a letter from the school committee letting the Council know what they intend to do and how much they actually need for the Referendum to go on. Councilor J. Burlingame stated his opinion that the Superintendent should also provide Council with a letter as to what the school will be spending the Referendum money on. Councilor W. Steere stated his clarification that it is for the voters to know, not just Council. Councilor J. Burlingame stated that the information is needed to be able to put the question to the voters so they know what the money will be spent on. Councilor W. Steere stated that there is a time period for the school committee and the superintendent to give that information to the Council by July 7th if the referendum is to go forward on September 2nd, but it could be pushed to October if necessary.

R. Palazzo, Glocester School Superintendent, stated that the majority of money would go to restoring personnel; but she does not know what a plan would look like. Councilor W. Steere asked what R. Palazzo meant as to the majority of money. Councilor W. Steere stated that the intention was that people were losing jobs which is why he went with this whole thing. Councilor W. Steere stated that Council and the taxpayers need to know what the money will be spent on.

R. Palazzo stated that she understands completely but wants to make it clear that there are other unknowns as well, like evolving title money, federal money that have already been built into the budget that they might not get. R. Palazzo stated that there are a lot of moving parts. R. Palazzo stated that the majority of it, depending on what we get, would absolutely go towards restoring and retaining as many personnel as possible. R. Palazzo stated that we are also working on looking at what opening the buildings in the fall would look like with the current budget. R. Palazzo stated that she just doesn't know what the plan is or how detailed the plan is or if they will be able to give Council what they want by next week.

Councilor W. Steere stated his opinion of the need to have a plan or wait till October. R. Palazzo stated that she doesn't know the clarification of a plan as she is new to the town budget. R. Palazzo stated her opinion that she feels she has a pretty solid understanding of the current budget that was proposed but that the school did propose \$840,000 more than they got. R. Palazzo stated that right now the work is on restructuring things, looking at what they have and need to open schools and also the unknowns as to transportation placements and federal money.

Councilor W. Steere stated a suggestion to have Council send a letter outlining what we need and then it is on the school committee and the superintendent to come up with that information. Councilor W. Steere stated that if the school committee and superintendent can't come up with that information within the given time frame then can look at a later date.

R. Palazzo stated that she will come up with a plan as quickly as she can but she does not know how detailed the plan will be or that it needs to be.

Councilor J. Burlingame stated that the Town Council needs to be able to explain to the voters what the money will be spent on so the ballot question states the intent of the school department. Councilor J. Burlingame stated as an example that if the school's intent is to bring back all teacher assistants then the question would say the money is to bring back all teacher assistants.

Councilor W. Steere stated that the ballot question would not be worded in this manner but that rather an explanation would be provided with that information. Councilor C. Greathouse stated that the impression was that the referendum was to be for the appointment of those teacher assistants.

R Palazzo asked for clarification as she stated this is the first she is hearing of the need for a plan and she really needs to be sure school is set to open in September.

Councilor W. Steere stated that he is not sure if the bill has been signed yet by the Governor. Councilor W. Steere stated his opinion that Council needs that information to be able to adopt a ballot question that then needs to be approved by the state.

J. Fecteau stated that the final question needs to be sent to the state by July 14^{th.} J. Fecteau stated that she needs to have a Special Meeting of the Town Council so they can adopt the ballot question. J. Fecteau stated that once the Council adopts the ballot question that the Board of Canvassers has to have a meeting to certify the ballot question. J. Fecteau stated that once certified then question then goes to the state. J. Fecteau stated that the timeline is to get the question on the September referendum but if not then it could be October which would give another month.

Councilor W. Steere stated his opinion to get a letter to the school committee and superintendent tomorrow. Councilor J. Burlingame stated that Council needs to figure out what to say in the letter. Councilor W. Steere stated that D. Igliozzi has drafted a proposed letter and sent it to Council.

Burlingame to authorize the Town Council President and/or Town Solicitor to send a letter to the Superintendent of Glocester Schools and the School Committee for Glocester Schools as to a plan for what they will be spending the money on if we put this to a ballot and to have a special meeting on July 9th; seconded by Councilor S. I would respectfully request to appoint **Aaron L. Steere of Glocester to** a Patrol Officer II police officer position on the Glocester Police Department.

Aaron Steere is a highly qualified 21-year veteran of the Warwick Police Department and Brown University Police Department. Aaron Steere's transfer from the Brown University Police Department will be considered a lateral transfer to the Glocester Police Department. A complete police background investigation was conducted with no adverse or disqualifying findings. Aaron Steere comes highly recommended and will be an asset to the Glocester Police Department. The Rhode Island Police Officers Standards and Training Committee is set to approve his qualifications and lateral transfer on June 26, 2025.

I would further request this appointment take effect on **Sunday July 6**, 2025 at a Patrol Officer II salary of \$74,902.21 and a full benefit package in accordance with the current IBPO 638 collective bargaining agreement.

Aaron Steere will be on probation until July 6, 2026, and upon satisfactory completion of the probation period, Aaron will advance to the Senior Patrol status position based on the IBPO 638 collective bargaining agreement.

This lateral transfer appointment is needed to fill the recent Senior Patrol Officer resignation/vacancy in May of 2025.

I would respectfully request to appoint Paige M. Labossiere, age 21, of Coventry to the Rhode Island Municipal Police Training Academy commencing on August 4, 2024.

Her Rhode Municipal Training Academy salary will be \$750.00 per week until December 19, 2025, and she will be afforded all medical benefits according to the Town of Glocester policy handbook. All recruit candidates are required to have healthcare coverage while in the municipal police academy. The town will provide the opportunity to enroll the candidate as of August 4, 2025, to meet this stipulation if needed.

After successful completion of the Rhode Island Municipal Training Academy on December 19, 2025, Paige Labossiere will be granted a one-year probationary police officer position with the **Glocester Police Department**.

Mr. Wright stated that he was given 24 special events with 11 being live music events. D. Wright stated that live music events have been usually been on non-consecutive weekends. D. Wright stated that way they could have a special event one weekend and a live music event every other weekend.

Mr. Wright stated that the way it was written this year was that all events are to be held on non-consecutive weekends. D. Wright stated he is seeking clarification so that they can have live music every other weekend from April to October.

J. Fecteau, Town Clerk, stated that she pulled licenses from prior years and the license has been one that has changed over each year. J. Fecteau stated that the 2023 license states live music on non-consecutive weekends. J. Fecteau stated that in 2024 license states events to be held on non-consecutive weekends.

Councilor J. Burlingame stated his opinion that live music events were to be on non-consecutive weekends.

J. Fecteau stated a suggestion that she could listen to the audio of the meeting to confirm the motion that was made before any changes could be made if needed. Councilor J. Burlingame asked if a special event with live music is also considered a special event. J. Fecteau stated yes. Councilor W. Steere asked if there had been any complaints made to the police this past weekend's event. Chief Delprete stated none. Councilor W. Worthy stated that the Clerk would listen to the audio and then address as needed.

1. W. Steere, resident, stated his opinion regarding the proposal of another tax bill. W. Steere stated that the town has passed a tax bill that has increased by about 4% for each of the last several years including this year. W. Steere stated that now the proposal is for a second tax bill of almost the same amount. W. Steere stated his opinion that it is too much on the people of this town. W. Steere stated his opinion that many don't realize what is happening and many won't realize until it is over and they get a second tax bill.

Councilor W. Worthy stated that to be clear, the Council is letting the voters decide by a vote whether those teachers stay with us.

W. Steere stated that Council is not doing their job of taking care of the town. W. Steere stated his opinion that the Council and school committee have both let the town down. W. Steere stated that the school committee has done all their talk about the budget in executive session except for one time when they told people to vote

for the budget. W. Steere stated that now after the budget passed the school wants more money. W. Steere stated the school can't have it both ways.

Councilor W. Worthy stated that if W. Steere does not agree with the proposed referendum then he can vote no. Councilor S. Calise stated her opinion that she feels they agree but that the council was not in a position to make a unilateral decision without bringing it to the taxpayers.

W. Steere stated that the Town Council took over a mess from the school committee so now people will blame the Council when taxes go up. W. Steere stated he has been telling the Council for 3 years that a problem was coming.

W. Steere stated his opinion that things need to be cut back and a lot of people will not be able to live here and that the legislature is also part of the problem.

Councilor W. Worthy stated he agrees with W. Steere in that there are a lot of people who do not know what is going on.

W. Steere stated his opinion that Council still has a chance to cut back on this money. W. Steere also stated his opinion that if the people who have been laid off begin collecting unemployment that the school has to pay a lot of money which will add more to the deficit.

Councilor W. Worthy stated that we now need a Motion to Adjourn to Closed Executive Session.
