Worthy stated his opinion that the League does not look out for the small towns.

Councilor W. Steere asked if anyone had talked to other small towns about this matter. Councilor W. Worthy stated that Gordon Rogers, Foster Town Council member came and spoke on this subject at a meeting a year or so ago. Councilor W. Worthy stated that the matters of small towns are falling on deaf ears and we get no benefits from being a member.

Councilor W. Steere asked if anyone thought it would be worth it to have R. Rossi, Director of the League of Cities and Towns, come and speak. Councilor C. Greathouse stated her opinion that Council has not seen that the League has done much for Glocester. Councilor W. Steere stated that he agrees but wants to make sure that Glocester won't miss out on anything if we decide not to renew. Councilor W. Steere stated his opinion that he has not seen any positive benefit from Glocester being a member. Councilor C. Greathouse stated that she is not sure how much clout the League actually has when you look at what has been done.

Councilor W. Steere stated his opinion that the state has their own agenda. Councilor W. Worthy stated that he would rather put the money back into the General fund balance than spend it on the League. Councilors S. Calise, C. Greathouse and W. Steere stated their agreement.

1. K. Scott, Town Planner, stated that the project at Glocester Manton Library is Almost complete and that a required part of the project is the installation of a small plaque. K. Scott asked about the wording the Council would like on the plaque. K. Scott suggested that the plaque could read the Town of Glocester, the Town of Foster, and the Boards of Trustees for both Glocester Manton and Harmony libraries. Councilor W. Steere stated a suggestion to have the plaque read the Town of Glocester Town Council and the Town of Foster Town Council instead of just the towns with both boards of trustees.

Mosca stated that he has asked DEM for assistance in fast tracking the approval for the septic tie in or for an alternative. G. Mosca stated he is getting ready to ask the Council to go out to bid and stated his opinion that a general contractor should be included.

3. G. Mosca, EMA Director, stated that he has put in for an extension on the grant with RIEM A and he is trying to get it done now because he is hearing that there will not be any extensions next year.

King, 55 Blackinton Drive, stated that he filed a complaint with the State Fire Marshall's office on Jan. 30,2024 regarding damage to his window sashes, window panes and his chimney after blasting near his home on multiple occasions. G. King stated that the cost to repair the chimney on his 300 year old home is about \$75,000. G. King stated that J. Fecteau gave him the contact information for the blasting company's risk management office. G. King stated that his claim is being processed.
- G. King described the noise, the number of trucks, the long hours of work at the property, that he doesn't get notice before blasting and that he was not in favor of the blasting when the company came before Council.
- G. King thanked Council and J. Fecteau.
- 2. A. Rogler, Douglas Hook Road, stated a description of how his house rattles each time there is blasting. A. Rogler stated that his son's home is on the same road as G. King's and the blasting is scaring his grandkids. A. Rogler stated his opinion that this matter needs to be looked into and that people need to know.

XX. Special Town Referendum

A. Discussion, Vote, or Other Action on Establishing Town Referendum Discussion: Councilor W. Steere stated that there has been discussion about asking the town voters for additional money to fund the elementary school. Councilor W. Steere stated that the intent of the Council was to save some jobs. Councilor W. Steere asked the Finance Director if the School Committee had made the required adjustments to their budget.

E. Beltram, Finance Director, stated that the School Committee authorized the Superintendent and E. Beltram, Finance Director, to make the adjustments as to staff reductions. E. Beltram stated that she needs to confirm other items with the Superintendent but the Superintendent has been unavailable. E. Beltram stated that she expects to meet with the Superintendent on Tuesday.

Councilor W. Steere stated that the School Committee has not followed up as they said they would have a budget by this meeting and they do not. Councilor W. Steere stated that he has heard from a lot of people and they are not in favor of paying more taxes.

J. Fecteau, Town Clerk stated that, if it is Council's intent to hold a referendum, that August 19,2025 is the last day for the certified question to be sent to the Secretary of State.

Councilor C. Greathouse stated that the Council asked for a plan from the school and that has not happened. Councilor W. Steere stated that since the last Town Council meeting, there has been potential litigation filed against the town by the school committee. Councilor W. Steere stated that the Council has not received any confirmation as to how the money will be spent. Councilor W. Steere asked how can the Council ask the taxpayers to give more money without knowing how it will be spent. Councilor W. Steere stated that he has concerns about the money being allocated properly.

Councilor S. Calise stated that she attended the School Committee meeting that subpoenaed E. Beltram, Finance Director. Councilor S. Calise stated her opinion that the School Committee attorney berated E. Beltram for no other reason than that he didn't get the answer he wanted. Councilor S. Calise stated her opinion that there is no working with the school committee. Councilor S. Calise stated her opinion that the school committee is just going to expect the taxpayers to pick up the bill no matter what. Councilor S. Calise stated her opinion that even if there is a referendum, it still will not be enough money for the school because they are going to go after what they feel is owed to them from before. Councilor S. Calise stated that the school has been operating at a deficit for multiple years without a plan. Councilor S. Calise stated her opinion that the plan by the school committee is litigation and going after the taxpayers. Councilor S. Calise state her opinion that the town should not throw money at the school without a plan.

Councilor W. Worthy stated his opinion that the school committee has not come to Council for any extra spending in violation of the Charter. Councilor S. Calise stated that the school brought up multiple times their opinion that the town did not give them enough money but they never did anything about it until now.

Councilor W. Steere stated that he has been doing this for a long time and has never seen anything like it. Councilor W. Steere stated his opinion of likening this to the example of the Council being in a boat and they are drowning so we throw them a life jacket and they throw it back and then torpedo the boat. Councilor W. Steere stated Council's intent was to help. Councilor W. Steere stated that going back to the status that Council has heard nothing from the School Committee.

Councilor C. Greathouse stated that the School Committee had the adjustments made to bring the budget within the amount approved so they are finding a way to move forward.

Councilor W. Steere stated a suggestion to wait to make any decisions until the next meeting as there is not a full Council tonight. J. Fecteau stated that the next meeting would be too late for an October referendum.

Councilor W. Worthy stated his opinion that if a vote of Council were taken today about having the referendum or not that he would vote to not do it in October. Councilors S. Calise and C. Greathouse stated their agreement.

Councilor C. Greathouse stated that there are also costs involved in holding an election as there would be mail ballots and early voting days. Councilor C.

Greathouse asked J. Fecteau the proposed cost for this type of election. J. Fecteau stated the estimated cost as being about \$10,000.

J. Fecteau stated that if no question is submitted to the state then there is no election.
