I would respectfully request to appoint Brett Bonner age 29, of Glocester, Rhode Island to a part-time dispatcher position. Candidate Bonner is currently employed with Allied Security and Brown University Health, and has some previous dispatcher training and experience.

Candidate Bonner will need further training in both Glocester Police and Fire Training at an hourly rate of \$18.00 per hour. Once he successfully completes training he will be afforded a part-time hourly rate of \$24.50 per hour not to exceed

24 hours per week. There will be no fringe benefits with this position and will be effective Sunday August 24, 2025.

Mr. Bonner will fill the recent full/part time dispatcher resignation of Megan Anderson on July 6, 2025. This appointment is further contingent on Mr. Bonner successfully completing a police department background investigation.

Fecteau stated that the proposed zone change from Coluch Org. is to add an industrial use in the B-2 highway zone to be able to process sand, gravel and loam without being associated with an earth removal license. J. Fecteau stated that this would be a town wide zone amendment which would mean anyone in town in this B-2 zone would be allowed to process sand, gravel and loam without an earth removal license. D. Igliozzi, Town Solicitor, stated his recommendation that a new license be created that would

require annual renewal.
